S. R. O. No. 79/2010.—In exercise of the powers conferred by section 7 of the Consumer Protection Act, 1986 (Central Act 68 of 1986), read with rule 3 of the Consumer Protection (Kerala) Rules, 2005, and in supersession of the notification issued under G. O. (P) 24/2002/F, CS&CA dated 31st May, 2002 and published as S. R. O. No. 441/02 in the Kerala Gazette Extraordinary No. 760 dated 3rd June, 2002, the Government of Kerala hereby reconstitute the State Consumer Protection Council for the State of Kerala with effect from the 1st day of February, 2010 with the following members, namely :—

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per Section 7 of the Consumer Protection Act, 1986 (Central Act 68 of 1986), read with Rule 3 of Consumer Protection (Kerala) Rules, 2005, the State Government shall constitute State Consumer Protection Council for the State. The term of State Consumer Protection Council constituted as per G. O. (P) No. 24/2002/F, CS&CA dated 31st May, 2002 for a period of three years from the first of day of June, 2002 expired. Since the term of the Council is over Government have decided to reconstitute the State Council.

The notification is intended to achieve the above object.
