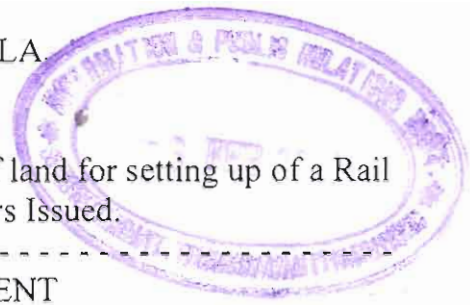

ORDER

In the Government Order read as first paper above, Government have accorded sanction for the acquisition of 900 acres of land for setting up of a Rail Coach Factory in Palakkad District under the Fast Track Project. In the Government Order read as second paper above, orders had been issued for the acquisition of the above land, by invoking urgency clause under 17(4) of Land Acquisition Act. As per the Notification read as third paper above Notification under Section 4(1) of Land Acquisition Act Also had been issued for the acquisition of the aforesaid land.

Later in view of the public agitation against the land acquisition, Government have requested RITES to visit the site again for determining an alternate site and the RITES team has reassessed the land requirement for the Rail Coach Factory. In the meeting convened by the Hon'ble Chief Minister on 13.01.2010 the matter has been discussed and directed the District collector , Palakkad to submit fresh proposal for acquisition of land for the Coach Factory. Accordingly the District Collector, Palakkad has submitted details of land available. According to the latest proposal as

per the reassessment of by the RITES Team now submitted by the District Collector, the total extent of land that can be made available to the Railways is 430.59 acres in Pudussery West village, Pudussery Panchayat as detailed below;

A. Land available on southern side of Palakkad-Kanjikkode Rail Line

1. Land resumed from Industries Department	142.91 acres
2. Land resumed from M/S Instrumentation Ltd	12.35 acres
3. Panchayat/ Government puramboke	3.27 acres
4. Vested Forest	92.75 acres
5. Private land to be acquired	99.02 acres
Sub Total	350.30 acres

B. Land available on northern side of

Palakkad-Kanjikkode Rail Line that

was resumed from Industries department 80.29 acres

Grand Total(A+B) 430.59 acres

As per GO read as 5th paper above it was inter alia ordered as under,

1. The orders issued in G.O (M.S) No: 40/2008/ Trans dated : 6-10-2008 G.O (M.S)No: 1/2009/ Trans dated : 2-1-2009 and the Notification issued vide No: 316/D2/ 09 Trans dated :19-1-2009 for acquisition of 900 acres of land will be cancelled.
2. Government orders and Notification U/s 4 and U/s 17 of Land Acquisition Act will be issued for acquisition of 99.02 acres of private land in Block No.35 of Pudussery West village , Pudussery Panchayat Land acquisition for the project will be done under Fast Track.

Accordingly the following orders are issued ;

(1) The orders issued in GOs read as first and second and Notification read as third paper above, for the acquisition of 900 acres of land for Rail Coach Factory, Palakkad are hereby cancelled.

(2) 99.02 acres of private land in Block No.35 of Pudussery West Village will be acquired for the coach Factory under Fast Track Programme. Fresh requisition in Form No.2 will be given to the District Collector, Palakkad for acquiring the above land and the District Collector will submit proposal for issuing Notification under Section 4(1) of LA Act and orders under Section 17(4) of LA Act to Government .
