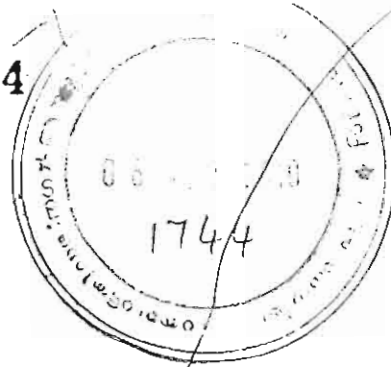

Subject: Filling up of one post of Superintendent in the Deptt. of Urban Planning (Town Planning Wing) Chandigarh Administration on deputation.

Sir/Madam,

I am directed to address you on the subject matter and to state that one post of Superintendent in the pay scale of Rs.10300-34800+RS.4200/- G.P. (Revised) in the Town Planning Wing of Deptt. of Urban Planning of this Administration, is to be filled up by taking employees on deputation from Central/State Governments. The employees holding analogous post on regul. basis and carrying the same or identical scale of pay. The terms and conditions of the deputation are as under:-

1. Period of deputation One year in the first instance to be extended from time to time or reduced according to requirements. However the period of deputation will not ordinarily exceed three years.
2. Pay The official will draw pay in his own scale of pay without any deputation allowance. In case the official is appointed on higher post, he will draw pay in the sanctioned pay scale of this Administration.
3. DA & Local Allowance According to the Rules of the Chandigarh Administration.
4. TA, Joining time and Transfer TA According to the Rules of Government to which deputed i.e. Chandigarh Administration

6. Leave Travel Concessions
Medical Concessions &
Accommodation

According to the Rules of Chandigarh
Administration.

7. Pension Contribution

The pension contribution payable by
the Administration will be regulated
under the rules of the Parent Govt.

It is therefore requested that the panel of the names of the suitable employees of your Administration/Departments who fulfills the above conditions and are willing to be considered for the post of Superintendent in the pay scale of Rs.10300-34800+RS.4200/- G.I. (Revised) and can be spared immediately in the event of his selection may please be forwarded to this Administration/Department. The upto date ACR dossiers of the employee alongwith bio-data and consent of the employee to work on transfer on deputation in the Chandigarh Administration.
