ORDER NO. B4-22094/05/DIMS. Dt. 20.11.2005

With the enactment and publication of the Right to Information Act 2005 by the Central Government, the Government of Kerala have decided to implement the said Act in the State forthwith. In the G.O. read above it has been directed to designate a senior level officer in each district as State Public Information Officer for providing information concerning each department to persons requesting for the same and to designate at sub district/sub divisional level officer as State Assistant Public Information Officer to receive applications for information.

As per Para 4 of the G.O. read above, the following officers of this department are designated as State Public Information Officers and State Assistant Public Information Officers for each District are noted below.
