ORDER

As per G.O read above, Government of Kerala has constituted ‘Kerala State Information Commission’ to exercise the powers conferred on and to perform the functions assigned to it under the Right to Information Act, 2005. The General Administration (Co-ordination) Department will be the Nodal Department of the State Information Commission.

It is stated in the circular read above that as laid down in the Section 4(1) of the Right to Information Act, all Head of Departments will take immediate steps to designate State Public Information Officers and State Assistant Information Officers for providing information concerning the Department to persons requesting the same. It has also been instructed in the circular that for providing information to the public as per the Right to Information Act 2005, all the Departments in the Government Secretariat has to designate the Officer in charge of the Parliament Section as Assistant Public Information Officer for receiving the Applications & Appeals from the public and the Joint Secretary / Additional Secretary of the Department as Public Information Officer and the Principal Secretary / Secretary of the Department as the Appellate Authority.

As per the directions in the circular, Government are pleased to designate the following officers of IT Department to the posts under Section 4(1) of the Right to Information Act, 2005 for providing information concerning the Department to the public: -
