#### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government of Kerala have received representations requesting to change the name of the territory "AYROOR KARA" in Ayroor Village in Pathanamthitta District in the State of Kerala as "AYIRUR KATHAKALI GRAMAM". The place has been adjudged as a hamlet for Kathakali, the unique artform of Kerala by the Ayroor Grama Panchayath in the year 2010. The State Names Authority in its meeting held on 24.07.2019, considered the proposal for changing the name and decided to recommend the matter to the Government of India. Ministry of Home Affairs, Government of India, New Delhi, as per letter no.11/21/2019-M&G dated 1<sup>st</sup> March, 2023, have conveyed its 'No Objection' to change the name of a territory "AYROOR KARA" in Ayroor Village in Pathanamthitta District in the State of Kerala as "AYIRUR KATHAKALI GRAMAM". Hence the Government of Kerala have decided to change the name of "AYROOR KARA" as "AYIRUR KATHAKALI GRAMAM".
