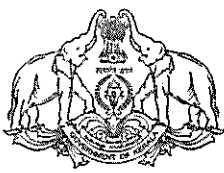

S. R. O. Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Section 3 of the Kerala State Right to Service Act, 2012 (18 of 2012), empowers every department of the Government to notify in the Gazette the services that will be rendered by the designated officer, the first appellate authority, second appellate authority and the stipulated time limit to implement the provisions of the said Act. Hence the Government have decided to notify the services rendered by the Home Department, the designated officer, the first and second appellate authorities and its stipulated time limit.

- The notification is intended to achieve the above object.
