Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Kerala State Right to Service Act, 2012 (18 of 2012) empowers Departments of the Government, Head of Departments, Local Self Government Institutions and Statutory Bodies to notify in the Gazette, the Services, that will be rendered by each of them, along with details of stipulated time limit, Designated Officers, First Appellate Authority and Second Appellate Authority. Accordingly, it is necessary to notify the services to be rendered by the Scheduled Tribes Development Department and the Officers in respect of such services as stipulated in the said section.

The notification is intended to achieve the said purpose.
